

Take Five Dogcare requires all dogs who are attending Daycare, Boarding, or receiving Grooming Services have current Rabies & Distemper/Parvo (DHPP) vaccinations. We **strongly recommend** the Bordetella vaccination as well. Ensuring dogs are properly vaccinated is an important part of providing a safe environment for clientele.

Vaccination Requirements

We ask that every dog at <u>daycare</u> is old enough to be fully vaccinated (complete puppy series of vaccinations) therefore dogs must be 16 weeks or older. There is no age limit for boarding and grooming services.

- Rabies: Required by 6 months of age as this is required by state law. New Hampshire accepts a Medical Rabies Waiver Form signed by a licensed veterinarian.
- Distemper/Parvo (DHPP): Required.
 - Exemption is accepted if the Take Five Dogcare Vaccination Waiver is signed, <u>and</u> a written statement is issued by the dog's veterinarian outlining the waiver of the vaccine.
- Bordetella: Strongly Recommended
 - o Exemption is accepted if the Take Five Dogcare Vaccination Waiver is signed.

Vaccination Records, Vaccination Waiver (if needed) and Veterinarian Statement (if needed) are required to be on file with Take Five Dogcare **prior to services being rendered**.

Vaccinations as Stated in the Client Agreement

3. It is solely the Pet Owner's responsibility to ensure that the Pet is properly vaccinated by 'Proof of Vaccination Certificate'; DHPP (Distemper, Hepatitis, Parainfluenza, Parvo) and Rabies. If your Pet is unable to receive the Rabies vaccination for medical reasons, Pet Owner is required to provide an immunization exemption certificate from their primary care veterinarian and agrees that Take Five Dogcare will follow state required protocols in handling the Pet, or their Pet will not be permitted to receive any services from Take Five Dogcare. The Bordetella vaccine is optional. If Pet Owner does not vaccinate their Pet for Bordetella, or DHPP, Pet Owner hereby agrees to assume complete and sole responsibility for the decision to not vaccinate Pet(s) for Bordetella and/or DHPP, and hereby represents that Pet Owner fully understands the risk. Pet Owner hereby agrees to indemnify and hold harmless Take Five Dogcare, its employees, owners, agents, and other pet owners from any and all claims made by any member of the family or any other person in relation to all damages or injuries that may occur, whether to Pet Owner (or Pet Owner's friends or family) or to Pet. Pet Owner also represents that the Pet is free of any infectious disease, including contagious parasitic problems, whether internal or external (including fleas and ticks), and is free of any contagious skin disorder within a fourteen (14) day period of arrival at Take Five Dogcare. Pet(s) that have not completed their entire series of vaccinations due to young age may not yet be fully protected and, thus, Pet Owner of this/these Pet(s) hereby accepts any risks of infection.

Please Note: For all reservations on or **after March 19, 2021**, DHPP & Bordetella exemptions must have a completed Take Five Dogcare Vaccination Waiver (**plus** proper documentation from their veterinarian for DHPP exemptions).
